

RESOLUTION NUMBER 7337

WHEREAS, Section 16-411 of Beatrice City Code authorizes the Mayor and City Council of the City of Beatrice, Nebraska to designate streets or portions of streets as “Snow Emergency Routes” and “Snow Priority Routes” by Resolution; and

WHEREAS, the Mayor and City Council desire to designate such Snow Emergency Routes and Snow Priority Routes.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BEATRICE, NEBRASKA:

SECTION 1. That both sides of the following numerated portions of the streets are hereby declared to be “Snow Emergency Routes” when such emergency pursuant to the Beatrice City Code is declared by the General Manager of the Board of Public Works or his/her designated representative:

Beaver Avenue	6 th Street to 13 th Street
Court Street	City Limits to City Limits
Ella Street	3 rd Street to 6 th Street
Grant Street	2 nd Street to 6 th Street
Hospital Parkway	6 th Street to Hickory Road
Lincoln Street	6 th Street to 33 rd Street
Northgate Blvd	6 th Street to Hospital Parkway
3 rd Street	Ella Street to Court Street
6 th Street (US Highway 77)	South City Limits to North City Limits

SECTION 2. That the Board of Public Works shall place “Snow Emergency Route” signs on the above designated routes where such signs are not already properly in place.

SECTION 3. That both sides of the following numerated portions of the streets are hereby declared to be "Snow Priority Routes" when such advisory pursuant to the Beatrice City Code is declared by the General Manager of the Board of Public Works or his/her designated representative:


