

RESOLUTION NUMBER 7836

WHEREAS, the City of Beatrice, ("City") and the County of Gage, ("Gage"), entered into an Interlocal Cooperation Act Agreement on October 2, 2017, for the purpose of providing ambulance service in certain areas of Gage County, Nebraska (the "Agreement"); and

WHEREAS, the Agreement was for a three (3) year term ending on June 30, 2020; and

WHEREAS, on September 21, 2020, the City and County executed a Letter Agreement extending the Agreement through June 30, 2021; and

WHEREAS, on June 21, 2021, the City and County executed a Letter Agreement extending the Agreement through June 30, 2022; and

WHEREAS, on June 21, 2022, the City and County executed a Letter Agreement extending the Agreement through June 30, 2023; and

WHEREAS, on October 16, 2023, the City and County executed a Letter Agreement extending the Agreement through June 30, 2024; and

WHEREAS, on August 19, 2024, the City and County executed a Letter Agreement extending the Agreement through June 30, 2025; and

WHEREAS, on October 200, 2025, the City and County executed a Letter Agreement extending the Agreement through June 30, 2026; and

WHEREAS, the City and County desire to extend the Agreement through June 30, 2027.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BEATRICE, NEBRASKA:

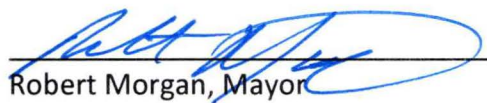
