The City of Beatrice is accepting bids on two (2) separate parcels for the cutting and removal of native grass located on the following properties: a parcel on top of the City well fields consisting of 65 acres; and miscellaneous properties within the City of Beatrice consisting of 28.3 total acres. All bids must be received by the City Clerk, 400 Ella Street, Beatrice, Nebraska by 2:00 p.m. on December 30, 2016. The City reserves the right to reject any and all bids.

Parcel A – City Well Field

Location: The parcel is located near the intersection of Elm Road and West 75th Road.

Acres: Approximately 65 acres

Parcel B – Miscellaneous City Property

Location: Various parcels throughout the City including Prairie park, Water Park and 4th & Sharpless

Acres: Approximately 28.3 acres

- Bids shall be submitted on a per acre basis for each parcel separately.
 - Each parcel will be awarded separately.
 - You do not have to bid on each parcel.
 - The City does not certify as to the type of grass to be cut.
 - All parcels must be cut once per year. Additional cuts may be allowed upon the City's determination.
 - Prior written approval by the City is required prior to additional cuts.
 - The term will be a three (3) year lease.
 - Baled hay must be removed within two (2) weeks of cutting.
 - Annual payment will be due June 1 of each term year.
